



**1) The programme fees shall be as published on [www.merit360.org](http://www.merit360.org)**

2017 WorldMerit360 UK Participants:

a) This fee shall be payable by way of:

- i. Deposit of \$150 paid once approved for the program.
- ii. The cost of operating WorldMerit360 is £2500 per person. We require you to fundraise a minimum of £1200 towards this, at which point you will be confirmed your place at the WorldMerit360 gathering in the UK.
- iii. The minimum £1200 to be paid in full before the 1<sup>st</sup> of May or as otherwise agreed by the Merit360 Team with you in writing.

b) Accepted means that you have gone through all applications, received your confirmation email, official acceptance letter and commitment agreement.

c) Fees are only refundable as set out in the 'Refund and Cancellation Policy' section below.

d) Fundraising will be conducted through your Merit Panel and World Merit CIO will receive all of the money directly minus and transaction fees. If you have funds readily available to cover your fee, you can personally make a donation through this site to contribute to your minimum fee following the closing date of the application process.

**2) Additional Costs:** By participating in the programme you will acknowledge the need to pay **additional costs, not covered by World Merit**, for services completed by third parties. Fees are set at the discretion of the third party who completes that service and may vary depending on time of booking. These additional fees may include (but are not limited to):

- Visa's for the UK – It is your responsibility to obtain a visa for any countries you may travel to whilst on WorldMerit360, World Merit will not cover any visa costs.
- Though World Merit operates within the visitor regulations of host countries, entry to those countries can be denied by that countries border agency, at their discretion. There will be no refund in this circumstance.
- Return flights UK – We advise you not to book your flight until you have received confirmation of your visa.
- Medical insurance – You are required to have medical insurance before you leave your own country. World Merit will not cover any medical costs incurred.
- Travel insurance – World Merit takes no responsibility for loss or damage to your personal belongings
- Any travel expenses to the Embassy/Consulate
- Any travel expenses incurred in your own country
- Any travel expenses incurred outside of the WorldMerit360 programming dates
- Expenses taken outside organised schedule of WorldMerit360, this includes any additional food, travel and leisure expenses.

You agree to pay these additional fees as they arise. Failure on your part to do this will result in your application being withdrawn from the programme.

### 3) Services you are entitled too.

(a) Once you have paid the £120 deposit you will be entitled to:

- Customer service and support with your application before you leave your home country
- A profile of your application
- A PDF document version of your application that you can use to promote your place on the program
- Fundraising Pack which will guide you in your fundraising experience
- Sponsorship Pack which you can take to potential sponsors and supporters

(b) Once you have paid your £1200 fee you will be entitled to the following whilst in the host cities in the UK:

- Food: Organized breakfast, lunch and dinner each day during the program, choice of dining is the sole discretion of the Merit360 Team. If the Participant requires additional food or meals, then the Participant will be responsible for the entire additional charges.
- Accommodation will be provided on a shared basis. The choice of accommodation is the sole discretion of the Merit360 Team.
- Communication: World Merit collateral, support documents and Merit360 hand-outs will be provided by the Merit360 Team.
- Transport to and from all official activities/engagements and venues as arranged by the Merit360 Team. If the Participant misses provided transportation or does not want to take the provided transportation, then the Participant will be responsible for the entire additional charges.

### 4) For your application to be complete and ready for you to start the program in, you must complete all of the below:
